# From the Department of Public Instruction (DPI)

## Resource to Share with Families at IEP Meetings

Each year districts across Wisconsin complete the Indicator 8 Family Engagement Survey. Over the last several years, about one fourth (25%) of parents report that schools do not provide them with information about one or more community services for their child with an IEP.

To support IEP team conversations about available statewide and community resources, DPI developed <u>Statewide and Community Resources for Families with Children with Disabilities</u>. This one-page printable resource can be shared with families at IEP meetings to help find additional support through family support organizations and county services.

DPI also plans to develop a companion video later this year to help for IEP team facilitators introduce this resource. You can find this and other family engagement resources on the DPI

#### **Survey Summaries for the Indicator 8 Family Engagement Survey**

The 2024-25 Indicator 8 Family Engagement Survey summary is now available. Indicator 8 measures the percentage of parents with a child receiving special education services who report that schools facilitated parent involvement as a means of improving services and results for children with disabilities.

This family engagement survey is more than a tool for measuring current efforts; it also serves as a resource for planning evidence-based and parent recommended practices to strengthen family engagement in a child's education.

Administrators and educators are encouraged to use the following resources to build beliefs, skills, and systems that support effective family engagement in special education, IEP meetings, and their children's education.

Families are also encouraged to examine these results and see what others across the state feel about their involvement in their child's education and the IEP process.

# **\$**529 College Savings Plans - Saving for a Student's Future, Including Students with a Disability **\$**

We greatly appreciate Chelsea for bringing this information to WSPEI and our Connector readers!!

Just as there is no "typical" student with an Individualized Education Program (IEP), there is no one-size-fits-all path after high school. Some students may be college-bound to a traditional 4-year university, with plans for graduate school or beyond. Other students may opt for a 2-year college to pursue an associate's degree or certificate program.

Registered Apprenticeship programs in Wisconsin have grown to include both the trades and other career pathways like healthcare and information technology. Alternatively, some students may finish their education at high school graduation, with a transition to adulthood that focuses more on daily living responsibilities.

Whatever path the student selects, the <u>Wisconsin 529 College Savings Program</u> offers families flexible tools to support their child's future. Administered by the State of Wisconsin's Department of Financial Institutions, this program is designed to help families save and invest for future education expenses and includes unique benefits for students with disabilities.

#### What is a 529 College Savings Plan?

Named for section 529 of the IRS tax code, 529 college savings plans are offered by states to help families save and pay for the cost of future education.

Unlike a standard savings account, funds in a 529 are invested, and any earnings grow tax deferred. Withdrawals are exempt from state and federal taxes when used for Qualified Higher Education Expenses.

Wisconsin offers two options for a 529 plan:

- 1. Edvest 529, which can be opened at Edvest.com
- 2. <u>Tomorrow's Scholar</u>, which is available through registered investment advisors and fee-only planners.

Contributions to either plan qualify for a Wisconsin State income tax deduction. For the 2025 tax year, contributions up to \$5,130 per student being saved for can be deducted from state income.

#### What can 529 funds be used for?

Despite the name, "Qualified Higher Education Expenses" include not just post-secondary education, but also some K-12 expenses.

For example, recent expansions now allow **529 plan funds** to be used for:

- K-12 tuition,
- · Books and curricular materials,
- Tutoring (with certain limits), and
- Educational therapies for students with disabilities (such as occupational, behavioral, physical, and speech-language therapies—when provided by a licensed or accredited practitioner).

Starting **January 1, 2026**, the annual cap for using 529 plan funds on qualified K-12 expenses will be \$20,000 per student (\$10,000 in 2025).

► Keep in mind that Wisconsin has a 365-Day Rule, requiring that funds be kept in the 529 account for 365 days before withdrawal if you are claiming the Wisconsin income tax deduction. More information for Wisconsin taxpayers can be found at the Department of Financial Institutions, <u>WI College Savings Program</u> website.

Once a student graduates or exits high school, 529 funds can be withdrawn to pay for the costs of their college or post-secondary program, including **tuition**, **housing and food** (if they are enrolled at least half time), **books**, **computers**, **and more**.

Qualifying post-secondary programs include:

- Degree-seeking programs at colleges and universities,
- Certificates.
- Professional credentialing
- Registered Apprenticeship programs

Students are not limited to attending school in Wisconsin, as funds saved in a Wisconsin 529 plan can be used at an accredited institution anywhere in the United States, and at some qualifying educational institutions abroad.

#### **Rollover to ABLE Accounts**

An ABLE (Achieving a Better Life Experience) account is a savings and/or investment option for people with disabilities who qualify. If a family has funds saved in a 529 college savings plan, and they later find that an ABLE account would better serve their child's needs, they can easily rollover

# From Wisconsin Board for People with Developmental Disabilities

# BPDD Statement: Promised increase for special education doesn't materialize for schools, students

The state budget did not implement the Governor's original proposal to raise the special education reimbursement rate from 32% to 60% sum sufficient funding:

The Wisconsin Assembly passes legislation that would let teachers decide which students they keep in class:

Full state Assembly passes AB 613 and AB 614

BPDD testimony

#### What do these bills do:

- Make it easier for teachers to take students out of classrooms if the teacher says the student's behavior is disruptive. Under the bill, the definition of "disruptive incident" is broad and gives a lot of room for the teacher to fit many common behaviors into the definition.
- Add time consuming paperwork requirements that can delay a student's return to the classroom.

Require the school to notify all parents of every student in the class each time a student is
removed from the class and say how the removed student diminished the quality or quantity
of instructional time provided to the class.

#### **Action steps you can take:**

- Contact your State Senator with your thoughts on this bill.
- <u>Contact the Governor</u> with your thoughts on these bills. This helps the Governor decide whether to sign or veto a bill that gets to his desk.

# "Sounding the Alarm on School Avoidance" Building Parental Awareness and Strategies to Break the Cycle

- Do you have a child or a student struggling or avoiding going to school?
