### **Public School Open Enrollment**

The open enrollment application period for the 2026-27 school year is February 2 - April 30, 2026 at 4:00pm.

(You must download or save the form prior to completing it electronically. Once the form has been completed, submit it to the school district to which you are applying.)

What is Open Enrollment: The inter-district public school open enrollment program allows parents to apply for their children to attend public school in a school district other than the one in which they reside.

The Department of Public Instruction's [Open Enrollment page](#) and [Open Enrollment Special Education webpage](#) provides information and resources for parents who choose to enroll their child in a different district than the resident district.

It is a local school board decision to create open enrollment policies as they relate to students with disabilities and those local school board policies can set limits on the number of students who receive special education services through an IEP are able to be open enrolled in their district. Both the nonresident and resident school districts may deny an application for reasons specified in state law. If an application is denied by either the resident or nonresident school district, the parent may file an appeal with the DPI within 30 days. The DPI is required to affirm the school district's decision unless the DPI determines that the decision was arbitrary or unreasonable.

## **Indicator 8 Family Engagement Survey**

Each year, the WI Department of Public Instruction (DPI) requires 20% of Wisconsin school districts to take part in the Federal Indicator 8 Family Engagement Survey data collection as part of the district's self-assessment. The survey is offered to all parents of children ages 3-17 who are receiving special education services and support through an Individualized Education Program

(IEP). Indicator 8 identifies the *percentage of parents with a child receiving special education services who report that schools facilitated parent involvement as a means of improving services and results for children with disabilities*. The survey is confidential. DPI will use the survey results to improve services to children and youth with IEPs and their families.
