# Do you know about this Special Education process?

#### Making a referral for a Special Education Evaluation and Child Find

If someone believes a student has a disability which requires special education services, the person can make a special education referral. Upon request, the school district is required to evaluate a child for eligibility for special education services. Anyone can ask the school to decide if a child needs special education, including you, the parent, a teacher, a nurse or a doctor can ask. This request for evaluation is called a referral.

The public school district(often referred to as the LEA) is responsible for locating, identifying, and evaluating all children with disabilities within the schools under its jurisdiction, including private and religious schools.

Once a referral is received, the school district has up to 15 business days to decide if more tests are needed. The school district will ask for your permission if more tests are needed. The school district has up to 60 days from when they get your permission to test your child and decide if your child qualifies.

The school district has up to 30 days AFTER your child qualifies to:

- Write an IEP (Parents are an important member of an IEP team)
- Decide where your child will receive special education services and tell you in writing.

A referral must be written. You can send a referral letter to the principal or special education director. A referral letter should include:

- The date the referral is being made.
- Say "This is a referral for special education."
- Tell the child's first and last name, date of birth, and school (if enrolled).
- State your name, address and phone number (parent, guardian)
- Explain why you think the child might need special education services. Be specific about the concerns you have.
- Send your referral to the Director of Pupil Services or the District's Child Find email.
- Ask for a receipt that the referral has been received.

#### What is Child Find?

Every Wisconsin public school district is responsible for locating, identifying, and evaluating **all children ages 3 - 21 with disabilities** within the schools under its jurisdiction, including private and religious schools who may qualify for special education services.

If you suspect your child may have a disability, contact your local school.
